The Moving on Team

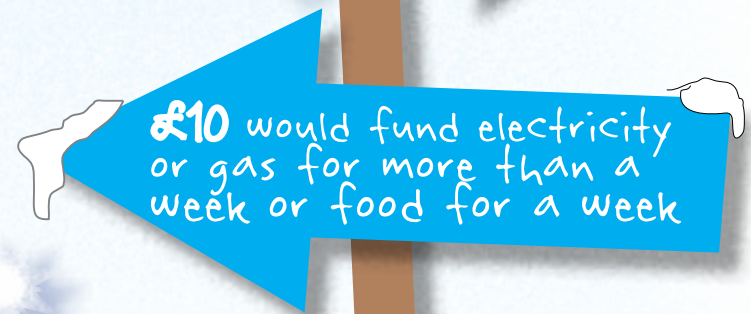
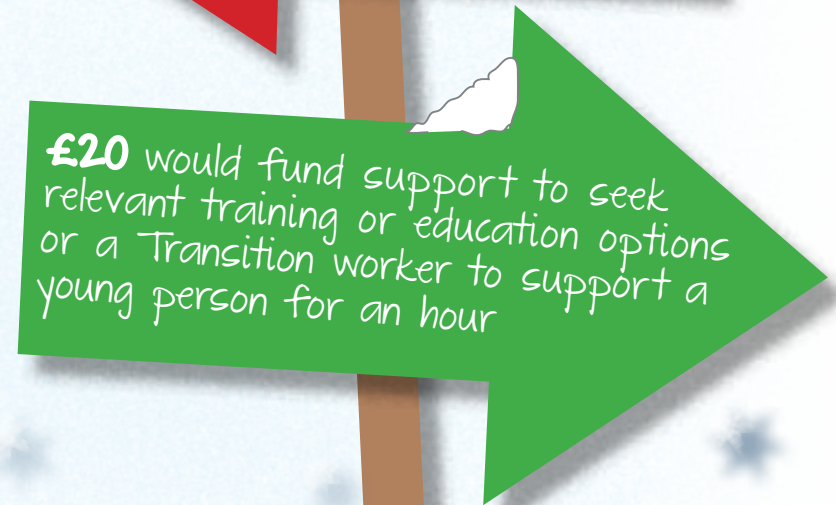
This invaluable service is totally funded by **Break** charitable income

Mentoring provides individual **support** for young people in or leaving care. Volunteer Mentors develop non-judgemental, **trusting relationships** with a child or young person, and engage in supportive, purposeful activities to support and encourage **positive change**.
